Re-registration for the 2012-2013 school year

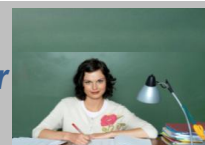
We will be sending you the re-registration forms for the 2012-2013 school year along with all the instructions, around February 6th. You must complete all required information and sign every page (front and back in some instances). Please return these forms in your child's bag before February 23rd 2012. For the students residing in foster homes or group homes, the forms will be mailed directly to the parents or the legal guardians.

Tax benefit

If you are providing for your child under 18 with a severe and prolonged mental or physical functional impairment, you are probably eligible for the tax-free Child Disability Benefit (CDB) which is paid monthly and you are also eligible for the Canada Child Tax Benefit (CCTB) and the Children's Special Allowance (CSA). The eligibility criteria are listed on the T2201 Disability Tax Credit Certificate form. **Have these forms filled and signed by your family physician.** You must pay the fees if required by the physician. **Please note that completing this form or any income tax forms is not**

part of the school's professional staff mandate.
