THE PETER HALL SCHOOL FOUNDATION

The Peter Hall School Foundation began its philanthropic work in 2001. It was established to enhance the work undertaken and conducted by the Peter Hall School, a school that welcomes students, aged 4 to 21, francophones and anglophones, with an intellectual disability, autism spectrum disorder or psychopathology disorder, with or without an associated disability. The Foundation provides educational, recreational, sporting and cultural support to nearly 500 students each school year.

SOME HIGHLIGHTS OF 2021... in times of pandemic

- . The **19**th **edition of our golf tournament**, scheduled for June 8, 2020, had to be cancelled due to the pandemic;
- . The **19**th **edition of our Wine and Cheese Tasting Evening**, which was due to take place in the fall of 2020, also had to be cancelled due to the pandemic;
- . The 3^{rd} major fundraising campaign, and expected to end in the spring of 2021, with a financial target of \$1.9 million, had to be paused and extended until 2022.

The Peter Hall School Foundation, like all charities, faced significant challenges in 2020 in the face of significant revenue losses and a need to find ways to maintain funding for educational projects tailored to our clientele of special needs students.

And we succeeded!

EDUCATIONAL PROJECTS AND 3RD MAJOR FUNDRAISING CAMPAIGN

Through the exceptional generosity of individual donors, parents of students, employees, board members and members of the fundraising committee, suppliers, corporations, private foundations, a religious community and our two MPs, who responded to our call, and for some of them, to make additional donations to us to others already generously granted, we received "pandemic donations" that enabled us to achieve our goals for full funding of educational projects that were on our 2020 agenda, and to continue to increase revenues from our 3^{rd} major fundraising campaign.

The Peter Hall School Foundation was able to fund the following educational projects:

- One fifth of six payments of \$6,720 for the purchase of an educational minious on both school campuses (re: students aged 4 to 21)
 This project, funded over six years, will cost a total of \$40,320;
- ➤ The purchase of a 'Nutritower' for the Côte-Vertu campus (re: students aged 13 to 21) This project cost \$1,390;
- ➤ The purchase of adapted outdoor play and sports modules for the school park at the Côte-Vertu campus

 This project cost \$60,560;

The Peter Hall School Foundation received a major donation at the end of 2020 to fund the following educational and technological project:

The purchase of 35 interactive whiteboards (TBIs) for the two school campuses (re: students aged 4 to 21)
This project cost \$106,661;

And the Peter Hall School Foundation also received a total of \$194,000 in 2020 to the 3rd major Fundraising campaign, which allows us to confirm a total of \$1,018,533 for the \$1.9 million target... we have reached the million mark and we thank you for that!
